## What you need to know

- You can only salary package airport lounge membership for yourself, not for family members
- There is no business use requirement
- Paywise have negotiated a Corporate discount with Qantas Club, which is available to all Paywise members (complete the form overleaf to apply for a Qantas Club membership).

## What to do next...

### Step 1

Whether you are renewing Qantas Club or joining for the first time, simply complete the Qantas Club information form (page 2) and return to Paywise.

### Step 2

Paywise will contact you and arrange payment of your Qantas Club membership

### Step 3

If you have already paid for your Airport Lounge Membership, complete a Payment/ Reimbursement Claim form and submit to Paywise along with a copy of the Tax Invoice and/or receipt.

### Step 4

Paywise will set up deduction(s) from your payroll (for an amount and timeframe agreed by you) and make payments to your nominated bank account (until your entire claim has been reimbursed).

# QANTAS Club Information Form

**Please complete all areas in the form below, this information is required by both Qantas and Paywise to arrange your Qantas Club membership.**

Payment of the Qantas Club must be via your credit card. A Member Services Consultant will contact you to obtain your credit card details. Qantas will issue you with a receipt via email within a few days of the membership being purchased. This receipt must be forwarded to Paywise along with a completed reimbursement claim form.

Your Qantas Club Card and pack will be issued by Qantas within 10 business days. Should you require use of the lounge prior to receiving your card, you may do so at domestic airports before your card arrives, however if you are travelling internationally you will need to present the actual Qantas Club card. If you would like the Qantas Club card quickly, Qantas will courier it within 3 working days at a one off cost of \$30.

**NOTE:** Your Qantas Club Card and accompanying information from Qantas will be sent to the current address you have on your Qantas Frequent Flyer membership. There is no opportunity for Paywise to change your address or have it sent to another address. We recommend reviewing your personal details with Qantas ([qantas.com.au/frequentflyer](http://qantas.com.au/frequentflyer)) prior to submitting this form.
